Title I, Part D, Subpart 2, Prevention and Intervention Programs for Children and Youth Who Are Neglected, Delinquent, or At-Risk – Intent and Purpose: Establish prevention and intervention programs for children and youth who are neglected, delinquent, or at risk.

- Transition programs
- Dropout prevention programs
- Health and social services
- Special programs to meet the unique academic needs
- Programs providing mentoring and peer mediation;

Title II, Part A, Preparing, Training, and Recruiting High-Quality Teachers, Principals, or Other School Leaders - Intent and Purpose: Title II, Part A, provides resources to LEAs for the following: to increase student achievement on state academic standards, to improve the quality and effectiveness of teachers, principals, and other school leaders, to increase the number of teachers, principals and other school leaders, to provide low-income and minority students greater access to educators

Title IV, Part A, Student Support and Academic Enrichment - Intent and Purpose: To improve the academic achievement of all students by increasing the capacity of LEAs, schools, and communities to provide all students with access to a well-rounded education, to improve school conditions for student learning, and to improve the use of technology in order to enhance academic outcomes and digital literacy of students
